

Introduction and explanation of the 2015 Orchidland Voice petition to the Court:

What follows is the Petition asking for dissolution and receivership of OLCA, which Barbara Arthurs signed and attached to her lawsuit against OLCA. Both the lawsuit and the petition (see paragraphs 1 & 2) clearly state the requested outcome of dissolution and receivership.
