Paving Report

Paving Vote Results: The League of Women Voters' tally of the three paving proposals showed 191 votes for \$50 per year, 89 votes for \$100 per year for five years, and 47 votes for \$125 per year for five years. The current plan, \$50 per TMK to be voted on annually, received the majority of votes, as is reflected in the billing accompanying this newsletter.

The billing you receive in June is for the MRMA (Mandatory Road Maintenance Assessment). The MRMA is \$65 per TMK, if there is no special use permitted. Our special use fees will be posted on the website. The website also has our budget for the current fiscal year. The Paving Assessment money is used only for paving main roads; the MRMA is for maintaining all the roads. Last year we paved a section of Auli`i Dr.; this fiscal year we have paved additional sections of Pohaku Dr. and 40th Ave. Ilima and Laniuma are next on the paving schedule, followed by Orchidland. We are also trying to do something more permanent to solve the flooding problem at the corner of 39th and Pohaku Dr.

As a rough estimate it costs about \$70,000 to do each two-block increment. The \$74,000 that is currently in the paving fund is being used for 40th. As more roads get paved we can spend

additional time and money maintaining the side roads. Please kokua and pay your Paving Assessments as soon as possible-and if you are behind on paving or road maintenance fees, please try to pay what you owe. It benefits the entire community.

We are entering the wet period for this side of the island & expect to see road conditions deteriorate related to the amounts of rain we receive. Until we can get more funds to pave the main roads, both those roads & the side roads will suffer. Say a little prayer for moderate rainfall.

Cell Tower Update

On September 28th Joe Lipinski and Bob Ely, representing Orchidland, along with the 3 most impacted neighbors, met the Verizon representative to discuss the relocation of a cell phone tower that Verizon proposes to build on a private lot about 600 feet NW of the corner of 35th and Orchidland. A tentative agreement was reached whereby the tower would be relocated about 500 feet to the east and adjacent to some commercial property, and the design of the tower changed from a monopole to a disguised, or "stealth", tower. In return the Orchidland Board would withdraw its objection to the Special Use Application. The Board subsequently voted and agreed provided those two changes were made. We have just been notified by the Verizon Project Manager that he was not able to convince his management and/or the property owner of the proposed new location. So, it looks as though we continue on with the contested hearing (scheduled for Monday, October 24th). Results of the hearing will be posted on the website as soon as they are available.

Qualified OLCA Voters

Before a ballot is counted by the League of Women Voters or a voter card is counted (one vote per lot) at OLCA general membership meetings, a lot owner must have paid all fees voted upon by the general membership. These fees include the Mandatory Road Maintenance Assessment, the incremental paving fee, and the one-time \$10 lot assessment (used to purchase our Community Lot). The OLCA Financial Records Keeper, Lily Chan-Harris, provides the League of Women Voters and the OLCA Board of Directors the TMKs of lot owners who are qualified to vote.

A Word on Albizzia Trees

Driving through Hawaiian Paradise Park is a good lesson in why one wouldn't want to allow albizzias to grow uncontrolled. Although they have a graceful and initially lovely look to them, they are extremely fast-growing, unstable, invasive, and provide an ideal habitat for coquis. One tree can reach a 3-foot diameter in almost as many years; when the wind blows, branches fall in a tangle onto everything below and eventually choke out many life forms in an otherwise diverse landscape. Large trees are dangerous, toppling in high winds. Coqui frogs are drawn to their shade and complexity of structure and, once there, are extremely difficult to control. These trees spread very quickly, both through seeds carried in the wind and by underground runners. Please, if you have young trees on your property, do something about them while you can: the most effective way is to score the bark all around the bottom of the trunk in about a 3- to 4-inch ring. The ring cut around the trunk should be cut deeply enough to cut through the cambian layer. You can also cut, clip or chainsaw these trees, but growth will return if the proper treatment is not done at the time of cutting. This includes spraying the freshly cut or severed trunk with CrossBow or Remedy and should be done within 60 seconds of the cut. This is done most easily with two people, so bring a friend! If you would like to have a beautiful tree with a similar look to grace your property, the poinciana-either the dwarf or the large one-will do very well. Thank you for your consideration.
